

立法會換屆選舉啟動禮政總舉行

李家超：選賢能任議員至關重要

司局長籲有能之士 參選為港出力

【香港商報訊】記者周偉立報道：2025年立法會換屆選舉將於12月7日舉行，第八屆立法會選舉提名期今日起展開。多名政府高官在社交平台發文，鼓勵有能之士參選，又呼籲市民於12月7日踴躍投票。此外，多個界別的團體都表明全力支持立法會選舉。

冀愛國愛港人士積極參選

政務司司長陳國基在社交媒體發文，呼籲有志服務社會的愛國愛港人士積極報名參選，並鼓勵市民積極投入參與選舉，在12月7日投票日，積極履行公民責任，投下手中的神聖一票，為香港選出賢能議員，共創更美好明天。他續說，相信不少愛國愛港的各路精英，已經為新一屆立法會選舉做足準備，全力爭取市民的認同和支持。

財政司司長陳茂波發文指，過去一屆立法會，讓政論政聚集經濟民生和香港未來發展，專業理性、實事求是，致力反映社會的意見和需求，並與行政機關之間良性互動，合力推動本港經濟和社會穩步向前發展。他表示，行政立法積極互動，可孕育更多創新意念和政策措施，推動經濟和社會進一步提速發展。

律政司司長林定國指，日前在韓國仁川出席APEC部長會議，他發言時分享了香港近來的一些重要改革，包括取締劣質劏房及改善勞工權利等，這些改革都是通過新制定的法律推行，證明第七屆立法會高效配合特區政府攜手建構一個以民為本、更公平的社會，他重申這是一個需要和值得大家支持的立法會。

籲所有選民踴躍投票

政制及內地事務局局長曾國衛於社交媒體指出，衷心希望並呼籲所有選民，在12月7日踴躍投票，一起「投入選舉，共創未來」。其他局長亦在社交媒體發文分享了他們對第八屆立法會選舉的看法。

另一方面，本港多個界別團體都發聲明表示全力支持立法會選舉。其中，房協主席凌嘉勤表示，房協全力支持立法會選舉，呼籲所有委員、員工和親友，及管理的出租屋邨及屋苑的居民踴躍投票，而各屋邨、辦事處及工地亦會配合選舉的宣傳工作，亦會為員工提供彈性安排方便前往投票。

而物業管理業監管局主席黃江天表示，熱切呼籲物業管理界同仁於選舉日踴躍投票。監管局稍後將致函全港逾800間持牌物管公司，呼籲其於所管理的物業範圍內張貼宣傳海報，鼓勵業戶積極參與投票。而醫管局、積金局等機構亦表示，會全力支持立法會換屆選舉，並會積極鼓勵所有員工投票。

多個團體稱積極配合宣傳工作

香港賽馬會表示，非常重視立法會換屆選舉，積極配合宣傳工作，將會透過馬會在十八區超過100個直接營運的處所及設施，包括馬會辦公大樓、馬場會員會所、場外投注站、公眾騎術學校、大館等，全方位向會員、顧客、超過2萬名員工，宣傳立法會選舉信息。

香港社福界心連心大行動及其轄下的心連心學院表示，相信新一屆立法會將在推進民生政策、推動社福界發展等方面發揮關鍵作用，為香港社會和業界發展注入新動能，並鼓勵全港市民及社福界積極履行公民責任，踴躍參與投票。香港社會工作人員協會亦呼籲，各會員及業界同工積極履行公民責任，踴躍投票，為社福界選出合適的議員。

公務員以身作則動員投入

選舉管理委員會主席陸啟康致辭表示，新選舉制度彰顯制度本身的廣泛代表性、政治包容性、均衡參與性和公平競爭性的特點和優點，為香港民主長遠健康發展打下堅實基礎。他表示，選管會的職責是確保選舉在公開、公正、誠實、安全有序、高效和人性化之下進行，香港公共選舉在公開、誠實及公平各方面，向來在國際有非常良好的口碑。

政務司司長陳國基、署理財政司司長黃偉倫及多名局長；貿發局主席馬時亨等公營機構管理層、公務員團體代表及商界等亦有出席啟動禮。出席啟動禮的各界人士，亦呼籲選民積極投票，並表示會於所在機構宣傳立法會選舉信息。

願各議員無論在什麼崗位，都身心康泰，事事順利。

在會議開始之前，多名議員在宴會廳一起共晉早餐，期間議員向梁君彥送上一張大心意卡，卡上有88名議員的簽名。梁君彥向每名議員送上一張印有手繪全體議員樣貌及會議廳的心意卡。而在本屆立法會最後一次大會續會中，多名議員辯論最後一個推動鄉郊旅遊議案後，隨即由梁君彥總結發言及宣布休會，全體議員其後在會議廳拍攝大合照。

非盡善盡美 但盡心盡力

梁君彥總結本屆工作時說，不敢說今屆立法會的表現盡善盡美，但肯定可

以說議員都是盡心盡力。過去4年，議員上下一心服務市民，以往立法會做不到的，今屆立法會都做到，形容是「事不避難、建言有為、守正創新、實幹有為」，為將來的立法會邁向更高水平，打下堅實基礎。

梁君彥又提到，衡量議會表現最客觀公道的準則，就是能夠做到「民有所呼、我有所應」。今屆立法會處理三隧分流、取消強積金對沖、規管劏房、網約車等關乎民生，積存多年的老大難問題，同時通過很多加強投資者信心、提升香港競爭力的政策措施，並歷史性成功為基本法第23條立法。

他重申，立法會不是「橡皮圖章」，政府亦不是一言堂，今屆立法會充分顯示行政立法關係正處於良性互動的歷史性高位，共同目標為香港追回以前因為內鬥、內耗而失去的機會。他相信，只要每名議員、官員和香港人，本着「沒有最好，只有更好」的心態做事，在新時代下「香港一定掂」。他最後祝願各議員將來無論在甚麼崗位，都身心康泰，事事順利。

各大政團積極部署參選

自由黨派5人參選 梁進接棒張宇人

而自由黨宣布，將會派出5人參選。包括身兼自由黨主席的批發及零售界議員邵家輝，身兼副主席的選委界議員李鎮強將會競逐連任。另外，將會委派東區區議員阮建中、曾出任教育局政治助理的中西區區議員楊哲安，分途出戰港島東及港島西選區。南區區議員、現代管理(飲食)專業協會副主席梁進，將會接棒張宇人出戰飲食界別。

中總派2人參選 稍後公布名單

Per the Company President Xiong Chunying's nomination, the Board of Directors of the Company approved to appoint Ms. Li Weihua as the Chief Financial Officer, a Member of the Executive Committee, the Secretary of the Audit Committee under the Board of Directors of the Company, a Director of Jiangling Ford Automobile Technology (Shanghai) Co., Ltd., and a Director of Hanon Systems (Nanchang) Co., Ltd.

The aforesaid personnel changes shall become effective from November 1, 2025.

The Board of Directors of the Company agreed to authorize Ms. Li Weihua with full power to handle banking events between JMC and other financial institutions during the period when she serves as CFO of JMC.

There were 9 votes in favor of the proposals, 0 vote against, and 0 abstention.

This proposal has been reviewed and approved by the Audit Committee of the Board of Directors of the Company prior to submission for consideration by the Board of Directors.

2. For the reason of work rotation, the Board of Directors of the Company decided that Mr. Anderson Liu would no longer serve as a Vice President of the Company. The personnel change shall become effective from November 1, 2025.

There were 9 votes in favor of the proposal, 0 vote against, and 0 abstention.

Mr. Joey Zhu and Mr. Anderson Liu will not take any post in the Company after the aforesaid personnel changes. As of the disclosure date of the announcement, Mr. Joey Zhu and Mr. Anderson Liu did not hold any JMC share.

Ms. Li Weihua, born in 1977, holds a Bachelor's Degree in International Economic Law from Shanghai University of Finance and Economics and a MBA from Canada York University Schulich School of Business. Ms. Li Weihua has held various positions including Finance Analyst of Ford China, Finance Analyst, and Finance Manager of Ford Motor Research & Engineering (Nanjing) Co., Ltd., MFG Finance Manager, PD Finance Manager, MFG Finance Controller, and PD Finance Controller for C and C SUV of Ford AP, CFO of Ford Lioho, CFO of JMC, and CFO of Changan Ford Automobile Co., Ltd.

As of the disclosure date of this announcement, Ms. Li Weihua did not hold any share of the Company. Ms. Li Weihua has no relationship with the Company, the shareholders holding more than 5% of the shares of the Company and their actual controllers, as well as other Directors, Supervisors and senior executives of the Company.
